1) Introductions to BSL AP and housekeeping

DESNZ welcomed the new Panel members. Introductions were carried out led by TO. Roles discussed and allocated to everyone present. An overview given of the relationships between BSL, Woodsure, and DESNZ. A brief explanation given for what the advisory panel is and its role with the Biomass Suppliers List.

2) Terms of reference and confirmation (proposed Self-Supplier network)

A Self-Supplier network has been proposed where those that nominated themselves for the AP role of SS would be encouraged to form a group of representatives to meet, discuss various issues and thoughts on behalf of the self-suppliers to enable and support the official AP Self supplier representative to feed that back to the panel. The BSL to work with Julian Power the SS AP representative to set up this network. Julian Morgan-Jones will serve as an advisory role within the panel.

8) BSL admin update

BSL Admin presented slides regarding updates, including legality and sustainability. This included an overview for what these aspects mean and what the Advisory Panel will be reviewing.

For future meetings BSL admin will share slides at least one week prior to an Advisory Panel meeting to allow members to prepare and share any comments. Note this was not possible in this meeting due to the elections being held and finalised shortly before the meeting and Terms of Reference had not been signed by all representatives.

9) DESNZ update

DESNZ has met with various stakeholders (individually and collectively) to discuss issues relating to NDRHI Policy. DESNZ will continue to consult various stakeholders in the new year to discuss the policy intent and if changes to Fuel Quality requirements in the regulations and how they are written. The panel agreed that the fuel quality subgroup should treat this as a priority and that any points for discussion can be taken to those meetings.

A description of the process of how a governmental consultation of stakeholders was given and that DESNZ will be following this procedure in the usual way.

10) OFGEM update

Ofgem had sent their apologies as they were unable to attend.

11) Fuel legality & sustainability meeting (sub group meeting) recommendations



Following a subgroup meeting, the BSL sent information to OPSS and are awaiting a response regarding duediligence processes. Once this response has been received, the BSL will advise DESNZ as of the importing of woodfuel from at risk countries and update BSL guidance.

12) Fuel quality and paper traders

A paper that had been deferred from the last Advisory Panel meeting was brought to this meeting by JMJ regarding Paper Traders and their treatment under the fuel quality legislation. A Paper Trader is a trader of woodfuel, often pellets, that doesn't handle the product itself but acts as a broker, subcontracting handling and any delivery to another supplier who may or may not be fuel quality certified. The legislation as written requires that the Paper Trader be registered with the relevant fuel quality scheme in one form or another and doesn't currently have further consideration for Paper Traders.

Discussion was had regarding the processes which could make this process easier for Paper Traders specifically with the ENplus scheme but was at the discretion of the ENplus certified company being subcontracted by the paper trader.

The paper will be considered, and the topic discussed by the Fuel Quality Subgroup, any key discussion points to be brought up in the next Advisory Panel Meeting.
